Call to Order

Leanne Liddicoat called the meeting to order at 4:00 p.m. and welcomed everyone. Introductions were made via Zoom Chat.

West Valley Innovation Center Presentation

Jed Watters presented the West Valley Innovation Center website; he gave an overview of the Career and Technical Education focused school. He presented updates of the student project-based learning programs and outcomes. Also noted there were new upcoming programs to be added to curriculum, expansion plans to include more grade levels & the goal of having students reach junior and senior level of work-based learning. A milestone update was given, two students have started apprenticeships at PEXCO through the AJAC apprenticeship program. Jed navigated the website, highlighting the informational details and links to access more information for the Innovation Center. Jed then presented on the Yakima Valley Regional General Advisor Council, a group made up of workforce professionals, educators, and government representatives. This group focuses on building connections for areas from Cle Elum, Ellensburg all the way down to Prosser, with the intent to bring community leaders and stakeholders together to ensure; grades 7 to 12 curriculum is aligned with and leading to the needs of the regional workforce, maximize work and impact all while connecting local schools to the community and its workforce. Amy Martinez asked Jed to elaborate on who is at the Innovation Center. Jed responded that the building is host to 7th through 9th grade curriculum students as well as the AJAC Manufacturing Academy program and community partners People For People and OIC of Washington who offer training services.
